The environment is everyone's business.




Laws require everyone to take reasonable steps to identify and manage their risks to the environment.

such as those relating to air pollution and noise and vibration.






Tunnels South





Tunnels South scope

- 16-kilometre twin tunnels from Cheltenham to Glen Waverley
- Procurement, launch and operation of four tunnel boring machines (TBMs)
- Construction of western tunnel entrance within Stabling Facility (eastern tunnel entrance is being constructed Initial and Early Works. Will be handed to Tunnels South upon completion)
- Tunnelling support facilities, including soil treatment, at Heatherton, Monash and Clarinda
- Station boxes at Clayton and Monash (including excavation and temporary structures)
- 55 underground cross passages linking the twin tunnels.

Tunnels South site investigations

Q2 2024 – Q4 2024

- Gap analysis has been undertaken given changes to scope and methodology
- Further site investigations are needed across the Tunnels South alignment
- Each location will comprise of
 - One day of service proving
 - 7 days of borehole drilling
- Many of boreholes installed will also act as a ground water monitoring points for the life of the Project
- Will notify community via monthly notice OR localised postcard and doorknock

Elder Street South access track

New access track into the Dingley Bypass road reserve underway.

Works due to be completed by early-July.

Kingston Road U-turn

New U-turn facility, east of Dingley Bypass.

Works due to be completed by early-July.



Eastern tunnel entrance

Piling of the d-walls started in early- April.





Piling started in mid-March.

Approx 70% piles have been competed.





*All timings are indicative and are subject to change

Traffic changes for June

- Elder Street South closed in both directions until early-July
- 24-hour road closure on Kingston Road between Dingley Bypass and Clayton Road for up to three days in late-June and early-July
- Dingley Bypass northbound closure for up to four nights between early-June and mid-June
- 24-hour closure of Route 631 bus stops 19, 20, 48 and 49 for up to three days between late-June and early-July. Nearest available bus stops are located on Kingston Road and Clayton Road
- Traffic management in place along Old Dandenong Road

Dingley Bypass road reserve	Moving power services	August – September
Dingley Bypass road reserve and Kingston Road	Moving telecommunications services	September – October
Old Dandenong Road	Permanent closure	Mid – late 2024





Noise Monitoring

- There are five noise monitors currently active within our work sites
- Noise monitoring is undertaken 24 hours a day

Between 20 February and 7 May:

- There were 16 occurrences where the monitors detected a spike in noise levels.
 - 14 instances were due to short term activity or plant directly adjacent to the monitor and not representative of offsite receptors
 - 2 instances were out of hours when works were not occurring.
- No additional controls have been required on site
