Design expected to be finalised by late 2020.







OTHER AMENDMENTS

- Inclusion of 1-39 Hobsons Road rail embankment for flood plain management
 - Involves constructing a retaining wall along the existing rail embankment to reduce the batter (slope) of the rail embankment
- Minor updates to station entry and forecourt
 - Landscape updates to reflect further design consultation with City of Melbourne
- Minor update of Childers streetscape design
 - The realignment of Childers Street between Ormond and Tennyson Streets has prioritised cyclists and pedestrians over car parking
 - Inclusion of a rail maintenance access point on Childers Street
- Editorial updates to reflect proposed amendments

West Gate Tunnel Works (Late April)


CONSTRUCTION UPDATE



WHAT'S BEEN COMPLETED

- TBM retrieval (Meg and Joan)
- TBM retrieval shaft V-shape infill
- Second concrete pour of tunnel entrance ground slab
- Pre-cast propping installation (3 of 9 props)
- Completion of 285 metres of capping beams (275 metres remaining)

EGRESS BUILDING PREPARATORY WORKS

Egress building

- Will be constructed adjacent to South Kensington station
- Provide emergency access to and from the tunnels
- House emergency equipment, and mechanical and electrical systems
- TBM retrieval shaft will become the building's foundations and basement

Construction

- Managed by Arden Station site civil team (Kim Mas)
- Below ground works including waterproofing, base slab and internal wall construction: ongoing until September 2020
- Above ground construction expected to commence late 2020 (TBC)

SUMP PILING

Works

- Installation of 36 piles to form the foundations for a sump box below the tunnel entrance
- Secant piling methodology (similar technique to the construction of the TBM retrieval box)

Timing

- Piling works: Mid-June to late July 2020 (prior to roof slab construction)
- Sump construction: Late 2020

Impacts

- Out of hours delivery of piling rig
- Piling works planned for normal construction hours
 - Anticipated periods of high-level noise from auger removing excavated materials
- Monitoring Covid-19 restrictions with the anticipated timing of works



D-WALL DEMOBILISATION

- Demobilisation of three cranes from Childers Street worksite
- Removal of silos, shipping containers, pipes, pumps and site offices from Hobsons Road compound (possible overnight transport required)
- Removal of bentonite gantry (anticipated in July)
 - Removal of horizontal section, and two vertical sections
 - Closure of Kensington Road, Hobsons Road, and Childers Street
 - Closure of Hobsons Road car park
- Further information on impacts and timing from late May onwards

Retrieval works (Western Portal)

- Completed Friday 17 April

Reassembly works (Arden Station site)

- TBM Joan fully reassembled
 - Undergoing testing and commissioning
 - Expected to relaunch mid-May
- TBM Meg reassembly approx. 50% complete
 - Expected to relaunch mid-June




CROSS PASSAGE CONSTRUCTION

Arden Station to Kensington

- Commencing in May 2020
- All works to occur underground from completed tunnels
- Access from Arden Station site
- Not expected to be audible above ground
- Approx. 6 months to construct each cross passage (undertaken concurrently)
- Construction involves:
 - Installing work platforms and bracing frames
 - Geotechnical probe drilling
 - Cutting through the tunnel walls using a wall saw
 - Excavating the cross passage with an excavator
 - Waterproofing the cross passage
 - Lining with reinforced concrete
