1.	 Welcome and housekeeping Louisa McPhee (LMP) welcomed attendees and opened the meeting, noting that David Solly (DS) was in attendance on behalf of Michelle Mayur. Matt Fregon (MF) gave an Acknowledgment of Country. LMP recapped previous action items, noting the recirculation of prior minutes and the ongoing progression of the Gardiner's Creek naturalisation. 	
2.	Works update LOR provided an overview of current and upcoming works in Burwood noting: The formal launch of the new park, with a community event celebrating the official opening on 21 May. Around 250 community members attended, with activities for children and coffee and crepes provided. The formal site establishment works in Sinnott Street Reserve are concluding, with ground levelling and hoarding to mitigate dust and noise complete. The tunnel access shaft will be completed in three stages planned over 18 months.	LOR









Day works are planned, with some overnight work required for equipment



	deliveries. Formal notices will continue to be given to residents, including door knocks, as well as engagement with key stakeholders. Future works for the end of 2023 will include utility relocations, network support facility installation, as well as cable removal - including along Burwood Highway.	
3.	Suburban Rail Loop (SRL) East tunnelling procurement milestone SRLA provided an update on procurement, noting: The recent announcement of a preferred bidder for the first tunnelling contract from Cheltenham to Glen Waverley. The contract is expected to be formally awarded in late 2023 to Suburban Connect. The two remaining bidders will progress to procurement of the second tunnelling contract, from Glen Waverley to Box Hill Tunnelling will commence in 2026.	SRLA

Structure planning SRLA presented an overview of the structure planning process, noting: The role of SRL precincts, noting the need for appropriate planning to cater for Melbourne's population growth. 6. Questions and actions

- David Solly (DS) asked if there are any plans to link up the cycling paths
 - SRLA acknowledged there is a gap in the current pedestrian and bike path routes and SRLA and Whitehorse City Council are aware and considering this. SRLA advised the current station plans have three new connections across Burwood Highway, two for pedestrians and one for cyclists.
 - SRLA are prioritising active transport to make it easier to walk and cycle to the stations
- John Wilson (JW) advised that the Gardiners Creek Trail can be dangerous due to some cyclist's behaviour and asked if there are plans to separate cyclists and pedestrians
 - SRLA advised sections of the new paths would likely be separated as part of the plan to naturalise Gardiner's Creek.
- LMP thanked everyone for attending.
- MF added that while at the announcement in Burwood last Tuesday 29 August he
 observed the new hoarding at the Burwood site. He said it put into perspective how easy
 it will be for future Deakin University students to travel to campus.
- SRLA advised the next PRG will be between late October and early-November TBC
