Jim Waller (JW)	2024 Program Overview: Presentation included project timeline, community focus, works focus and Jobs and Social Value overview				
Conor	SP: Is 2028 still the date for completion? JW: Yes, there is some contingency built into this.				
Kiernan (CK)	MG: With the desired completion date of 2028 is that going to come at the expense of residents and the environment having to live with an increase in dust, vibration and noise? For example, I drove up Greensborough Road this morning and the road and residences are covered in dust - is this standard what we can expect for the rest of the project or will it improve? JW: There will be periods where it will be like it is but as the team starts working underground this will improve. With the other packages coming on board, we are also considering if where possible we can do some 'blitz' works to reduce the amount of time some works will take.				
	MG: That may work but people will have to be given choices such as respite for 12 -18 months as this needs to be improved upon. You say you are rewarding contractors for retaining trees, I don't believe this has happened. JW: It depends on the design, for example the ramp locations were changed to retain homes which unfortunately meant more trees were lost. We will replace the trees that have been lost and return a lot of open space to the community such as sporting fields.

Action

MG: Parking is an issue since the project started. JW: Construction parking has been built but as the workforce changes overtime it's a massive task to educate and monitor everyone. We are working on building more parking.

MG: A compliment - I called the Contact Centre and was put straight through to NELP which is an improvement.

GJ: Is the increase in dust and noise permanent until the end of the project? JW: It shouldn't be, as we have increased dust mitigation and with the low grade of the road in the trench and local traffic only using the local roads. The area should feel quieter.

SP: Just planting the trees isn't good enough, what about their maintenance? JW: There is a maintenance plan in place for 25 years for the primary package. We are also building habitat which will also be maintained. The other packages will also have maintenance plans in place and the trees will be monitored and the ones that don't survive replaced. CK: If any members have a better idea how this can be done, please let us know.

SP: I've noticed as other projects are coming to completion more focus, more media attention is being placed on NELP. Is there a way that whilst acknowledging the issues media attention can be given to the 'good news stories' coming out of NELP such as employing priority job seekers and how lives are changed? JW: It would be good to have stories about real people and how lives can be changed through employment and focus on positive things.

Spark Works Update

Presentation included works updates on Watsonia, Lower Plenty, Tunnels and Community interactions.

MG: Are the community interactions shown just for Spark? KZ: Yes, this is just Tunnels for January, the M80 completion team will report on their own.

AM: Is it possible to have cameras showing works that are happening eg: the dirt going through the conveyor belt etc? KZ: We have time lapse cameras, and these videos are sometimes incorporated into the NELP monthly update videos on their website. We can explore this possibility.

M80 Completion Update

Presentation covered upcoming and completed works including Environmental and Sustainability overview and community engagement.

MG: Do you need to build a ramp to allow cars to pass over the rail lines? SL: No, the road will almost follow the rail line on a standard grade.

MG: Will there be public access to the new wetlands? BK: No, there is no public access, but you will be able to see it from the top of the hill near the radio tower.

MG: There will be approx 350 trucks per day heading onto the freeway? BK: Yes, approximately 1 truck approximately every 1.5 minutes - this will mostly be day works.

MM: Will there be more traffic lights on the Greensborough Bypass during works? BK: No, this will remain the same until the end of the works when the current lights will be removed.

SP: Will there be any changes to Greensborough Bypass? BK: There will be a new shared user path connection between the Macorna and Yando St bridges, the rest remains as is.

SP: And towards the Civic Drive roundabout? BK: No, our work scope finishes at Plenty Road Bridge.

SP: Where can I see the Marcona St Bridge upgrade. BK: You can view this on the UDLP website, the **existing** bridge will be replaced.

SP: Will there be any improvements to links into The Gorge? BK: The connection points will be enhanced but remain the same.

MG: Has consideration been given to the fauna (especially the kangaroos in Yallambie) during tree removal? LW: We have a kangaroo management plan and advise which areas an ecologist need to visit before tree removal.

SP: How are the offset Studley Park gums being maintained? LW: We have two Studley Park gums that are managed perpetually.

GJ: As trees contribute to air quality is there an assessment done when they are removed what the effect will be? LW: Yes, this is monitored and approvals are sought before works begin.

AM: Where will the entry/exit point at AK Lines be? SD: It will be off Grimshaw Street

	GJ: Is there temporary access at the moment at AK Lines? SD: There is currently partial plant access at Knight St, we are planning to close this access once the compound is established.

	MG: Will there be surface water sampling up and downstream of the project? LW: Yes, we are working with Melbourne Water on this.
	MG: Banyule Creek is eroding, is this being monitored? LW: We have engaged a sediment and erosion control expert to create our plans that go into our site environmental plan.
	MG: Are the community interactions just for January? KN: Yes
