Introduction

Suburban Rail Loop

Our city and state are growing. Melbourne will be a city of 9 million people by the 2050's - the size of London today.

We need more transport and more homes in the right places – and Suburban Rail Loop (SRL) will deliver both.

As both a transport and urban planning project,
SRL will connect our suburbs, slash travel times and ensure our city grows in the right places. It will support the delivery of more homes and housing choice where people want to live – on the doorstep of world-class public transport, services, jobs, schools, parks


For years, high population growth on Greater Melbourne's expanding urban fringe has been driving many households further from employment centres, leading to longer commutes, increased congestion and more crowded public transport.

This pattern of growth risks entrenching disadvantage, with inequitable access to good jobs, services, affordable housing, amenities and recreational opportunities.


We need to plan now to cater for that growth, create new affordable housing options in the middle suburbs and help Melbourne become a 'city of centres'.

SRL is part of a coordinated Victorian Government plan to not only transform our transport network, cut congestion, and slash travel times but also to boost housing and amenities around the new SRL station precincts.

SRL will help prepare our city and state for the future and safeguard our prized liveability.

SRL structure planning engagement program

A precinct is an area or group of neighbourhoods with a shared history and future role. SRL Precincts are the broader neighbourhoods around each new underground SRL station at Cheltenham, Clayton, Monash, Glen Waverley, Burwood and Box Hill.

SRL structure plans will respond to Melbourne's growth by setting strategies to guide decisions around land use, design and development. They will also guide transport, open space, sustainability and community infrastructure across the structure plan areas.

Successful strategic planning needs a vision to build on, to inspire feedback and to support the development of planning tools, such as structure plans and planning scheme amendments.

This is reliant on feedback from local governments, residents, traders, organisations and other interested stakeholders. That is why Suburban Rail Loop Authority (SRLA) is continuing to engage with the community and stakeholders throughout the structure planning process.

Building on previous consultation, Phase Two of structure planning engagement sought feedback on proposed Key Directions for each SRL East Precinct, from people who live, work, study in and visit these areas, as well as broader stakeholders.




Figure 1: Structure Planning engagement phases

Shaping the plans: Phase two engagement

Overview of engagement activities and participation

This phase of engagement ran from April to June 2024.

During this phase, we shared the feedback captured during Phase one of structure planning engagement and confirmed the final structure planning boundaries around each of the six new SRL East stations. We sought feedback on the proposed Key Directions that will help achieve the vision for the future of each SRL East Precinct.


Community engagement included a mix of online and in-person activities, however most feedback was gathered via an interactive website. Engagement also included workshops and briefings with the SRL East Community Panels and other stakeholders, including local councils.

The "What we heard" section of this report provides a summary of key findings and feedback received as part of this engagement phase.

Activities by some local councils and other advocacy groups opposed to development influenced response rates and sentiment in some precincts.

Online engagement

An interactive website was launched in late 2023 to gather feedback on the SRL Draft Precinct Visions. A refreshed version of the website was developed to capture feedback on the proposed Key Directions that will guide each future SRL East Precinct. The website was live from Sunday 28 April to Sunday 30 June 2024. The Key Directions are based on five themes that underpin structure planning for each precinct:



Empowering sustainability


This engagement sought participation from communities in and around the SRL East precincts via online emoticon prompts to understand to what extent people agreed with the proposed Key Directions for each precinct.

Respondents were also able to provide general comments. Feedback could be submitted via emoticon and free text format, and information was available in English, Greek, Traditional Chinese and Simplified Chinese.

This report provides a summary of key findings from the feedback received via the interactive website for each SRL East Precinct.





Figure 3: SRL East Key Directions survey responses and further comments by precinct

In total there were 5,464 responses including 3,633 survey responses and 1,831 additional feedback responses. A breakdown of responses by precinct is detailed in Figures 2 and 3.

In addition to submissions received via the website, we also received some feedback via email. The sentiment from this feedback is included in the "What we heard" section of this report.

In-person engagement

Across May and June 2024, the project team interacted with 427 community members at four information sessions and nine pop-up sessions held across Melbourne's south east.




Figure 4: SRL East Key Directions face-to-face engagement interactions

Community panels

During this phase of engagement, we also convened seven community panels (one panel per precinct and one overarching youth panel). Each of the six precinct community panels included approximately 25-30 community representatives that broadly reflect the demographic mix of each precinct. The youth panel included 15 community representatives aged 18 to 24 years old from areas along the SRL East alignment.

The panels' remit was:

To consider how Suburban Rail Loop Authority (SRLA) can deliver future precincts in Cheltenham, Clayton, Monash, Glen Waverley, Burwood and Box Hill that reflect the needs and aspirations of their local communities.

Over four meetings, we asked panels to consider and provide advice and ideas on three topics associated with population growth and social and economic development - housing, transport connections and community infrastructure.

The youth panel considered similar topics from a whole of corridor perspective.

The community panels process was completed in August 2024 with each panel providing its advice to SRLA on each of the challenge topics it tackled throughout the process.

We thank the many community members who participated in the panels and acknowledge their passion and enthusiasm for achieving great neighbourhood outcomes.

Stakeholder engagement

While community consultation was open, we ran a concurrent stakeholder engagement program which included meetings and technical workshops with councils, universities and others.

During this phase, we ran nearly 30 hours of workshops with Bayside, Kingston, Monash and Whitehorse councils, seeking their detailed feedback on the key directions under each of the five structure planning themes (Boosting the Economy, Enriching Community, Better Connections, Enhancing Place and Empowering Sustainability).

A summary of these workshops is provided in Table 1. We also received submissions from a number of stakeholders. Table 2 provides a list of stakeholder submissions received and the key themes addressed in each.

What we heard

Feedback topics that were consistent across all six precincts included the need to:



- Provide more affordable housing with good quality design
- Provide more public, open and green space while also protecting existing spaces
- Improve existing public transport connections, including pedestrian and cycling infrastructure
- Engage in open and transparent community consultation throughout the structure planning process.

Specific feedback received across the six precincts is summarised in the following sections.

Cheltenham

Using emoticon prompts, the community survey asked people to rate to what extent they agreed with the proposed Key Directions under each theme for the SRL Cheltenham Precinct.

People were also offered the opportunity to provide further comments about the proposed Key Directions.

Respondents were most concerned about the potential impacts of taller buildings including overshadowing and privacy. We're taking this feedback onboard and considering the appropriate heights for each part of the precinct that balances the need to provide for more housing while also safeguarding the lifestyles people enjoy today. We're looking to develop planning controls that will integrate larger developments into each neighbourhood, considering topics such as site landscaping and setbacks. Further details will be provided when we exhibit the draft structure plans and planning scheme amendments in Q1 2025 at which time the community will have further opportunities to provide feedback.



We received **803** further comments for **Cheltenham**

People were also offered the opportunity to provide further comments about the proposed Key Directions.

Respondents were most supportive of improving mobility throughout the precinct, encompassing pedestrians, active transport users, public transport users and car users. In particular, there is strong support for decongesting Clayton Road. We're considering how additional cycling and pedestrian routes, along with upgrades to the public realm over time, will help to make it easier and more convenient to get around. Monash Medical Centre, Monash Childrens Hospital and other health services will continue to be a major destination to meet the needs of a growing community. High quality midrise and higher density developments will ensure there are more housing opportunities, including for key workers, students and families.



We received **82 further comments** for **Clayton**

People were also offered the opportunity to provide further comments about the proposed Key Directions.

Respondents were supportive of diversifying the housing options within the precinct. In particular, there were many comments about the need to build apartments big enough for families to live in, and increasing the amount of student rentals available. The improved access from SRL East will give students and families more choices where to live, both across the whole corridor with easy access to Monash and in the residential neighbourhoods of the precinct. Through the structure planning process we are carefully considering how to increase the vibrancy of these neighbourhoods, with enhanced amenity for workers, students and residents. This includes considering how new and improved open spaces and high quality public realm can contribute to making great places.

People were also offered the opportunity to provide further comments about the proposed Key Directions.

Respondents were supportive of increasing the walkability and permeability of the precinct core, including crossing Springvale Road and moving between transport services safely. Respondents were also supportive of reducing car use and congestion within the precinct core to create a better experience for people visiting the hospitality and retail businesses in Glen Waverley. Through the structure planning process we are considering how high quality midrise residential developments will contribute to the ongoing vibrancy and activity in the precinct.

People were also offered the opportunity to provide further comments about the proposed Key Directions.

Respondents were most concerned about the potential impacts of taller buildings, with the majority of concern regarding potential impacts to wildlife in Burwood, overshadowing and more residents leading to increased car use. We are thinking carefully about how new buildings in Burwood should respond to the unique, natural setting. Guidance being prepared as part of the structure plan will highlight the importance of balancing amenity and growth of buildings, responding to their context and making sure they contribute positively to the public realm. By creating the opportunity for more people to live closer to their jobs, and improving access to public and active transport, the structure plans will seek to reduce people's reliance on cars.

People were also offered the opportunity to provide further comments about the proposed Key Directions.

Respondents were most concerned about potential impacts of further densification in Box Hill, including overshadowing, wind tunnels and visual amenity for people using the precinct at street level. The structure plan will emphasise the importance of Box Hill's streets in creating a healthy, active and economically prosperous place. We are carefully considering the potential impacts of new buildings on Box Hill's streets and public places, and the structure plans will include built form guidance that will enable the precinct to develop in a way that creates high quality, comfortable places for people to enjoy.
