# Notes from meeting

### Welcome and introductions - Mike Marasco

- MM welcomed the group and introduced Banyule Council representatives, Jonathan Risby and Paul Bellis, NELP and photographer Katherine Clay.
- JR explained previous Banyule Council representative David Bailey had stepped back from NELP CLG meeting presence, and the group would see more of Banyule Council representative Paul Bellis at the CLG (north).

### EES update and planning panel process - Michael Crossman

- MC provided an overview of the EES timeline and key aspects of the planning panel process.
- GC asked whether the EES Panel Hearings have been live-streamed before. MC said no hearings had been streamed previously due to lack of facilities. He didn't anticipate this happening for the project.
- DO sought clarification about the timelines for the EES exhibition. MC said the EES would be provided to the Minister for Planning in March and would likely be on exhibition before Easter pending the Minister's approval. The exhibition period was 30 days, not including public holidays.
- MG sought clarification about responsibilities during and post EES process. KJ said Works Approval would be prepared by the proponent and approved by EPA. The risk report section of the EES would cover risks and methodologies behind assessments. The Inquiry and Advisory Committee typically have five core members and sessional advisors who help write the report. Planning Panels Victoria identifies key expertise areas needing focus when arranging the committee's composition.
- GC asked how caretaker mode from a Federal Election would affect the Commonwealth processes that are part of North East Link, such as the Performance Environment Report going on exhibition. KJ said that no change would be anticipated as it's a public process and not political.

### CLG report and framework - Gemma Boucher

- GB took the group through the framework and CLG report taking considerations and welcomed feedback and suggestions from the group.

Much discussion followed. The next steps will be for the group to decide who will lead report writing. For example, a community and business representative from each CLG.
