PROJECT OVERVIEW

We're removing the dangerous and congested level crossing at Keon Parade by building a rail bridge over the road and building a new Keon Park Station.

The modern Keon Park Station will be in a new location on the south side of Keon Parade to improve access to the station, bus connections and to local shops.

Building a rail bridge over Keon Parade means we can remove this level crossing sooner, with less disruption for drivers and public transport passengers during construction.

The additional benefits of the rail bridge design include new local connections for residents and workers from Reservoir and Thomastown, walking and cycling paths and a new signalised pedestrian crossing across High Street at Hughes Parade.

The Victorian Government is removing six dangerous level crossings and building seven new stations as part of a \$2 billion investment to upgrade the Mernda line.

Major works are due to start in 2023, with the boom gates gone for good and the new Keon Park Station open in 2025.

Why the Keon Parade level crossing needs to go



More than 18,000 vehicles travel through this level crossing each weekday



Boom gates are down for up to 41 minutes during morning peak (7am to 9am)



33,000 passengers use the Mernda line each day



One serious crash and 24 near misses in the last nine years

Consultation

We asked the Reservoir and Thomastown communities to share what they value about the local area and what they want to see delivered as part of the project.

The consultation was open for four weeks from 28 March to 25 April 2022.

We hosted two community information sessions, a pop-up at Keon Park Station and local business doorknocks to inform locals and to seek feedback on the project.

To engage with the local community online, we promoted our engagement through social media, advertising and multiple email updates to project subscribers to encourage participation in the community survey.

The responses have highlighted what's important to the community about the local area and are helping shape the project design.

Later this year, we'll release updated designs informed by community input and will provide another opportunity for the community to shape the station precinct design.



We asked you to share your preferences, insights and feedback on the project.




Your major destinations



WHAT'S IMPORTANT TO YOU

From our conversations and surveys, we heard that accessibility, safety and connectivity were the top three priorities for the Keon Parade Level Crossing Removal Project.

What project features are important to you?





You told us that accessibility was the most important principle to be considered in the design of the Keon Parade Level Crossing Removal Project.

We heard that moving the station to the new location on the south side of Keon Parade will have a positive impact on accessibility, with many of you citing the need for multiple entrances to the new Keon Park Station.

Some of you highlighted the importance of better pedestrian access to local bus stops in and around the station precinct to improve station access and usage.

You also asked for the station design to include accessible features for people with limited mobility as well as prams, luggage or shopping trolleys, with mentions of a dedicated pick-up and drop-off zone and station lifts.



Safety

You would like to see a design that promotes and improves safety in the area, with mentions of passive surveillance, activated spaces and pedestrian safety.

You identified the need for more lighting, better visibility, and CCTV around the station precinct, to make the station area safer for residents and commuters.

We also heard that the current traffic conditions contributed to people feeling unsafe in the area.

Some of you cited dangerous behaviour from both drivers and pedestrians trying to avoid long waiting times on High Street and Keon Parade.



Better connections

Another common theme we heard was that you would like to see better connections between shops, parks and public transport facilities in and around the new station precinct.

Connections such as upgraded walking and cycling paths, safer ways to cross busy roads, and easy access between the station, High Street, and Johnson Street were all highlighted in your survey responses.

We heard that opening up the areas on either side of the rail corridor will connect local businesses to the new precinct, and that attractive landscaping and open space beneath the new rail bridge will result in better connections in Reservoir and Thomastown.

Car parking was also a common theme, with many of you suggesting that you'd like accessible car parking within the station precinct to provide more parking options for commuters.

PRIORITIES FOR THE **NEW STATION PRECINCT**

We asked what you'd like to see in and around the new Keon Park Station precinct:

Improved safety



'Security is a big issue in the area. Having CCTV cameras within the station and nearby areas would give residents and commuters a better sense of security.'

Better station facilities



'The new precinct should retain the open nature of the existing station, while providing more cover, added greenery and integration with other facilities.'

This station needs to be an easy place to park, to seamlessly connect to a bus, pedestrian friendly, an approachable, comfortable, pleasant place to wait away from the station's hectic surroundings.'

More greenery and landscaping



'This is an opportunity to improve the feel and energy of this area and enhance community way of life here. Consider adding community spaces to utilise the space more. This area is barely used, and the corresponding business strip would benefit so much from building this area up to include outdoor areas, planting, cyclist and walking paths, etc.'
