### DESIGNATION OF THE PROJECT AREA FOR A DECLARED PROJECT

Ferguson Street, Williamstown Level Crossing Removal Project

I, Richard Wynne, Minister for Planning, pursuant to section 95(2)(a) of the **Major Transport Projects Facilitation Act 2009** (the Act), designate the area of land shown on the plans signed by the Surveyor-General with references LEGL./20-061 Sheets 1 to 13 (inclusive) lodged at the Central Plan Office on 9 November 2020, and as generally indicated on the map in the Schedule, for the Ferguson Street, Williamstown Level Crossing Removal Project declared by the Premier to be a declared project pursuant to section 10(1)(b) of the Act and published in the Government Gazette on 16 November 2017.

This order comes into effect from the date it is published in the Government Gazette.

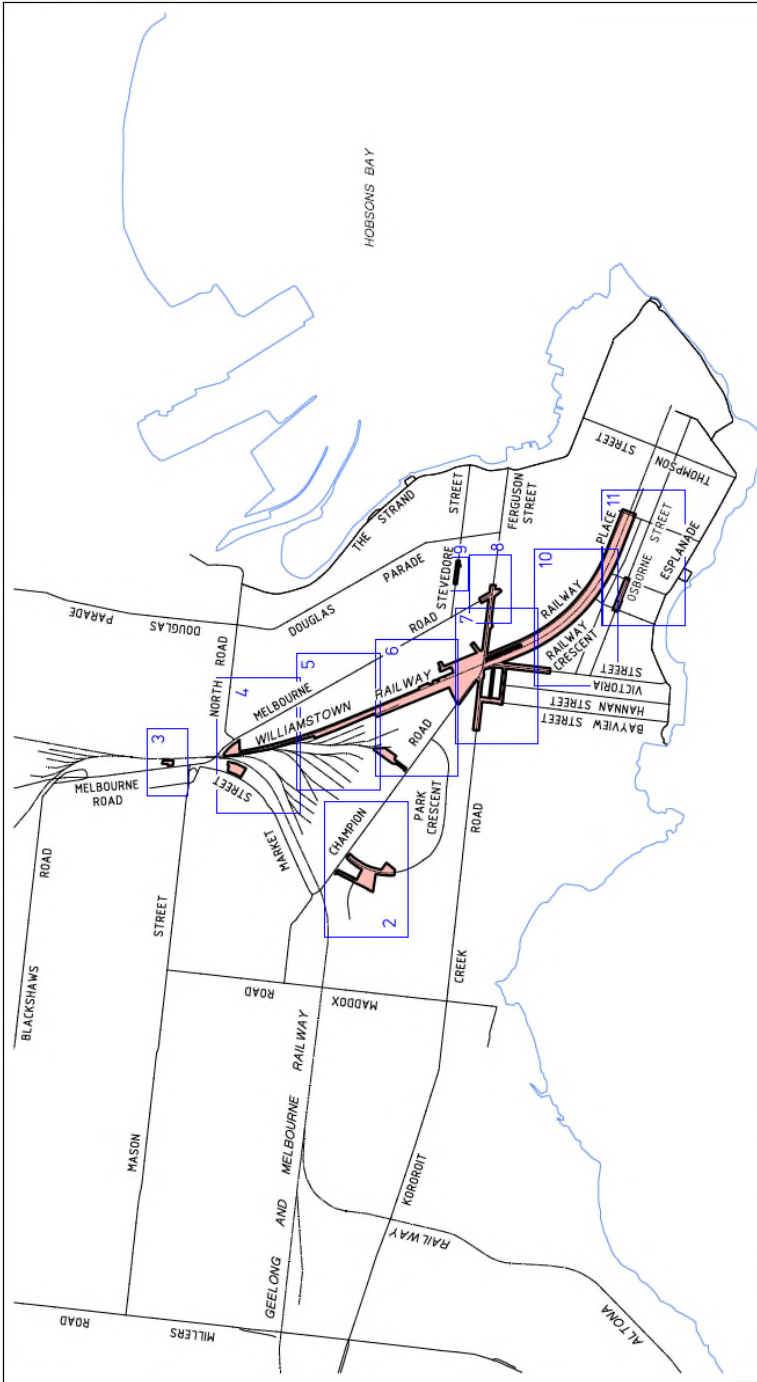
