	<b>MG:</b> Does it reduce the spoil waste that you have to take of site to dispose? RH: Yes definitely, there is an incentive to use site line materials on site - there are targets to divert 95% uncontaminated spoil from landfill.

	GJ: How much soil is excavated across all of NEL? Will soil being removed be increased as work progress? DP: Once the tunnel works starts the amount of soil excavated is between 25-30 thousand tonnes per day and other sites 10-15 thousand tonnes a day on top of that.
	<b>SP: Has the next TBM started arriving? DP:</b> It has started arriving and gantries have started to arrive. 1st TBM will start mid-year and 2nd TBM to start about a month later.





#### Owner Action

**GJ:** Has the recent hot weather presented a challenge? DP: It has, we have clear processes around when our workers stop works i.e., over 35 degrees. In the lead up to hot days, we are constantly monitoring and have drink stations established. Temperature underground is much cooler than above-ground.

**MG:** Are the complaints stats just from the North? What form are the project responses? DH: Yes, these stats are applicable to the North, project responses/ project engagement refers to general enquiries and meetings the team is having with the residents or responses via email

MG: What are you doing to reduce dirt on Greensborough Road? Are you treating that as an enquiry or action? - DH: Depends on the nature of the enquiry, if stakeholders are asking us what we are doing then we will provide a response of what the general procedures and project requirements are. If there is a particular area that needs more attention due to hot weather and/or windy days, then we will classify it as an action linked to an enquiry which we action right away.

**SP:** Do you update your dust mitigation processes on really hot days? DP: Yes, we always monitor and have the ability to bring in more resources on hot days. We turn on sprinklers and mist sprays to help reduce the amount of dust generated. Spark bring in additional water carts and street sweepers. Wheel washes always on regardless wet or dry day.

**GJ:** Is there community involvement in relation to choosing the artwork?. DH: Yes, we've reached out to the residents and sent out a poll via email and are receiving quite a few responses. In regard to Torbay Street we are still working through the design and the supplier has done a site visit. We are working out the next steps before engaging with residents and will keep you in the loop.

**SP:** Is there going to be a community pop up in the Watsonia Strip? EP: Watsonia Hub is always open Monday to Friday 10am to 5pm, and we get a lot of local community members coming through

#### **M80 Completion Update**

Presentation covered upcoming and completed works, centre median works on Greensborough Highway, Watsonia Station car park closure, sustainability, environmental and government policy update, feedback from the Watsonia Hub and Contact Centre

MM: Why can you use an excavator but can't use a chainsaw at night? BK: Noise modelling shows chainsaw/grinding is louder than forestry machinery. We are not cutting anything past 11pm MM: Do you check for wildlife before works take place? - SD: We have a wildlife management

plan and other relevant permits approved and in place.

MM: How are the interface works tracking with council? Will the town square works be finished before centre median works? JRi: We have traffic management meetings regularly with SPARK and AMA. Town square road works is broken into two parts - road works and landscape works. Road works is on track to finish by mid-year but not before centre median works. Landscape works will be finished by end of year.

JRi: Removing centre median through Elder Street intersection are you changing the intersections timing? There will be a very long pedestrian crossing there so our elderly residents can stop in the middle when crossing - SD: Any changes will occur from September to December. We will maintain a 2.5 centre median hold for pedestrians to cross through.

WC: What is the communication message for cars travelling towards the Ring Road and what messaging do you have planned to help with wayfinding. 2 weeks of on road messaging is not long enough given the high volume of traffic. KN: MTM have developed communications messaging and have dropped 9,000 DLs. Traffic management will be onsite to assist with wayfinding. NELP is working with AMA to get increased traffic management in the area outside of peak times.
