 - EACH OF THESE STRATUM PARCELS ABUTS THE UPPER LEVEL OF AN EXISTING STRATUM PARCEL AS SHOWN ON LEGL./18-011 AND IS THE EXACT SAME SIZE AND POSITION.
 - THE STRATUM PARCELS ARE IDENTIFIED WITH THE SAME ALPHA-NUMERIC PREFIX "T" OR "Y" AS THE STRATUM PARCEL THEREON BUT WITH AN "A" SUFFIX.
 - STRATUM PARCELS IN THIS VARIATION, THEIR CORRESPONDING AHD VALUES AND INDICATIVE DEPTHS BELOW GROUND SURFACE ARE SHOWN IN THE TABLE ON THIS SHEET.
