(CL) & Phil Emirali (PE)	CL: Borlase Reserve early works are being finalised and thanked residents for their patience.				
	 PE: Telstra Tower from Nell St to Rasheda St is 80% complete, residents will be notified as work progresses over the next four or five weeks. 				
	 PE: New Watsonia Station mobile tower was installed 24/05/22 and old tower will be removed Q4 2022. Watsonia station carpark works to continue to approximately Christmas depending on Telstra and Optus. Work is underway to keep as many parking spots open as possible, whilst maintaining safety and construction schedule. 				
	 CL: Watsonia Gas works to restart on 19/06/22 with Sunday works and traffic management over two weeks. Traffic will be able to enter northbound from Greensborough Road to Watsonia shops but will be redirected when traveling the opposite direction. Nearby residents and traders will be notified.

	 MG JR and RM discussed gift cards and future competitions. Learnings from the Watsonia Shop and Win competition, particularly around gift card issues could be better managed with advanced notice. JR suggested at least one month notice is needed. 				
	 NJ suggested Wave Pay could be better gift card provider in terms of ease of use. Incentives for businesses to facilitate the competition could increase the number of entries.
