	GJ: Have Trinity Grammar works been completed? SM: This site is Sparks now. GJ: I've seen some complaints about noise where works are near the entrance CL: We have moved out of there some time ago.

	FF: How many levels are there? SG: Two and the green roof FF: What are the provisions for electric vehicle and bicycle charging? SG: We are handing it over as future provisioned at this stage. FF: There are bicycle clips on the green roof and provisions are there for future electric vehicle charging? SG: Yes, that is correct

	<b>FF: Phase three and four dates are subject to change?</b> SG: There is a meeting with DoT this morning to seek approval for the traffic change. DH: Dates are also subject to weather. 	<b>FF: Are the 1500 trees that have been planted unable to be replanted in their original position?</b> <b>MH</b> : They are at various locations as close as possible to works, we work with Council on new locations when we are unable to plant near the original locations. Reinstatement of trees will be ongoing throughout the project. NP: We have a tree factsheet that will be sent with the minutes.
Shondelle	Tunnelling package design presentation
Matthews (SM) Tom McCann	Manningham Council have approved heavy vehicle movement through Ilma Court to where the properties have been demolished between the hours of 9am – 3pm. Residents have been notified and 6-10 trucks are expected to require access per week. This is a temporary arrangement until approximately mid December.
	Questions/Responses:
	Tunnelling package
	<b>GJ: What is a diaphragm wall?</b> SM: It's what the gradient/incline walls are called when you drive into or out of a tunnel. GJ: For the cut and cover or tunnelling? SM: Its how the gradient changes when you are driving down into the tunnel. TMc: A diaphragm wall is created using a rectangular pile which enables a more waterproof joint between the tunnel and cut and cover sections.
	JV: How is the used bentonite disposed of? TMc: It gets pumped into a waste truck and taken offsite and disposed of in a waste facility.
	<b>FF: Will there be bentonite plants at each end of the tunnel?</b> TMc: There will be one where each of the diaphragm walls is constructed (Manningham, Lower Plenty and Bulleen) the bentonite must be connected in by a pipe at each location.

	GJ: Are Facebook groups that oppose North East Link monitored by Spark? SM: I'm not sure, we may need to get a list of them and monitor. GJ: It would be great if Spark could address any concerns immediately. SM: Yes, that would be good - The works we were doing at Trinity were crossover works and there was some noisy saw cutting. Residents in the area were offered accommodation and respite for those nights. DH: It would be helpful if a list of those groups could be passed onto Spark and NELP. SM: There would be some items we wouldn't respond to but if people are asking questions it would be great to provide a response.
