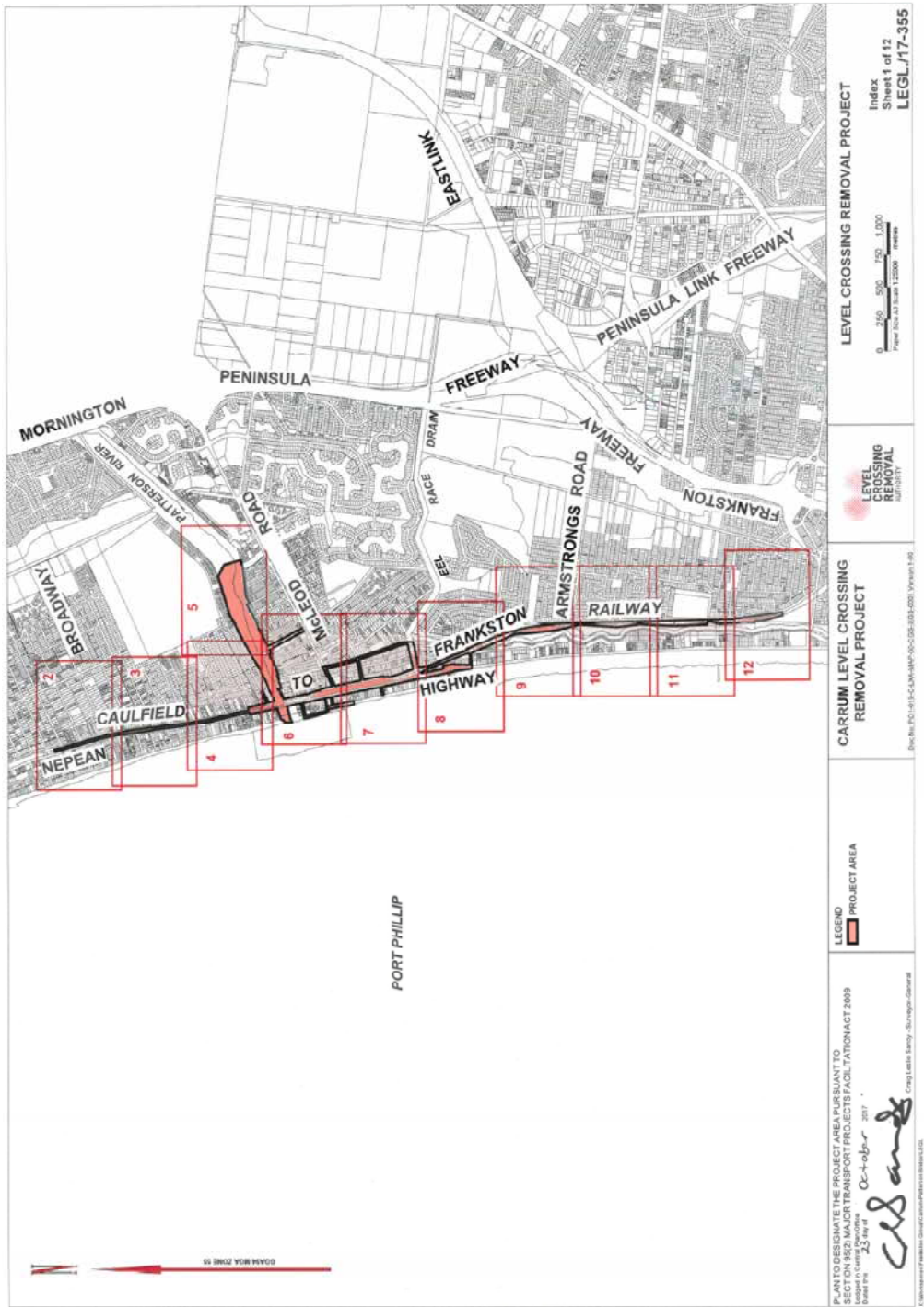

West Gate Tunnel Project

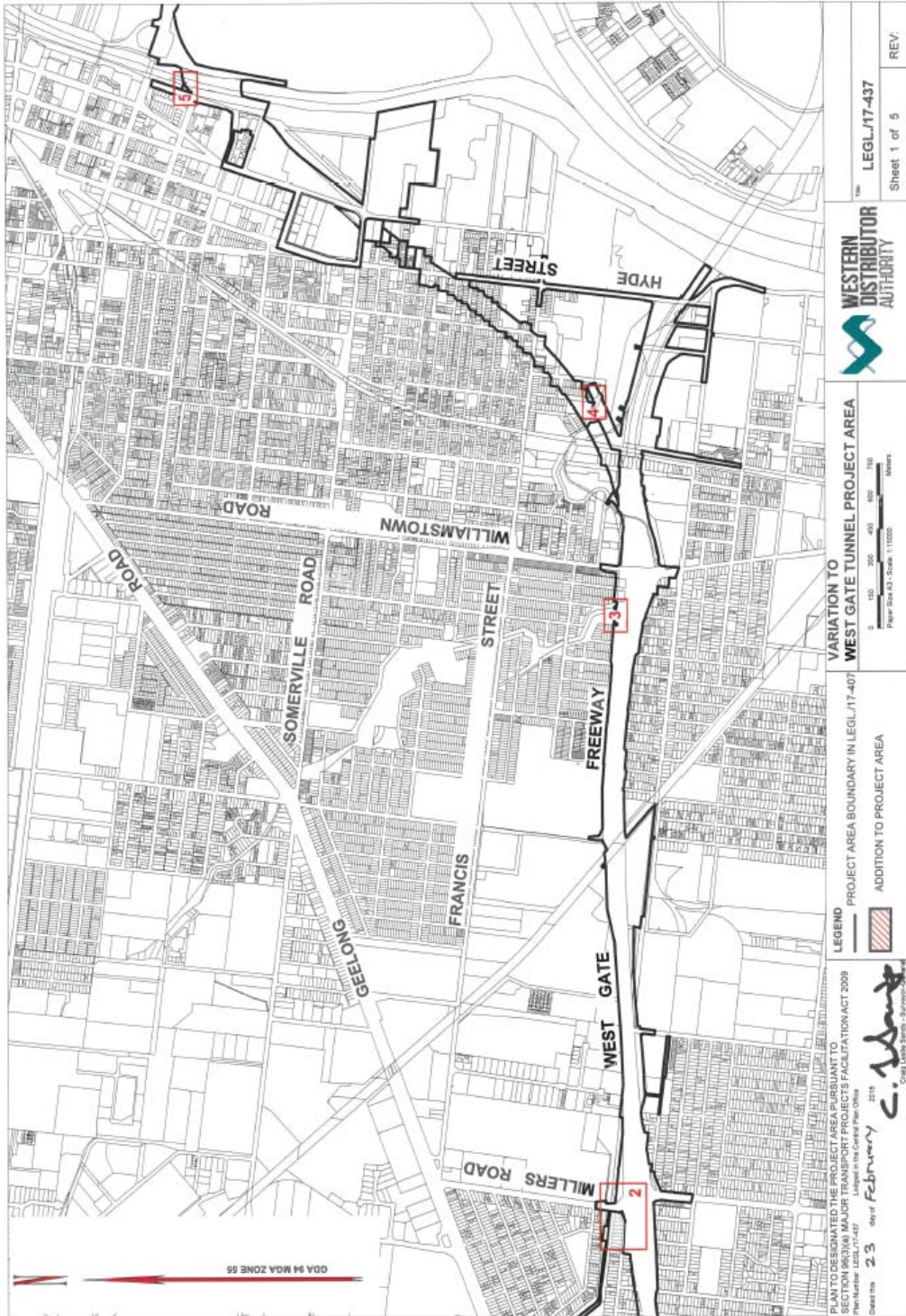
I, Richard Wynne, Minister for Planning, pursuant to section 96(3)(a) of the **Major Transport Projects Facilitation Act 2009** (the Act), increase the project area for the West Gate Tunnel Project by designating that land in the vicinity of the project area as is shown on the plans signed by the Surveyor General with references LEGL./17-437 Sheets 1 to 5 (inclusive) and LEGL./17-438 Sheets 1 to 3 (inclusive) and lodged at the Central Plan Office on 23 February 2018, to be part of the project area for the West Gate Tunnel Project, being the project formerly known as the Western Distributor Project declared by the Premier to be a declared project pursuant to section 10(1)(b) of the Act and published in the Government Gazette on 15 September 2016.

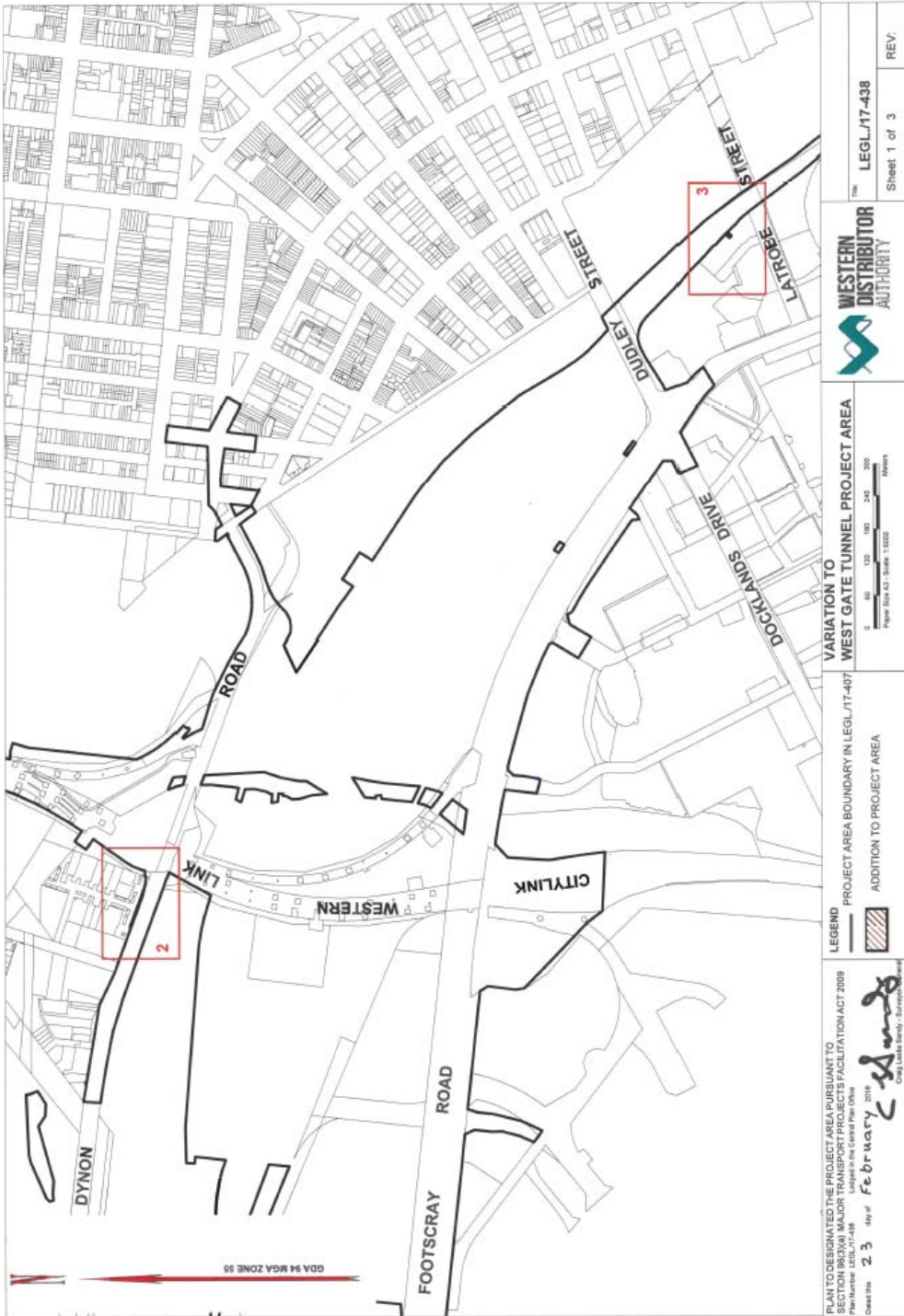
