Power of School Council to Grant a Licence in Relation to School Lands or Buildings

TITLE

1. This Order may be cited as Ministerial Order No. 928 – Power of School Council to Grant a Licence in Relation to School Lands or Buildings.

AUTHORISING PROVISIONS

2. This Order is made under sections 5.10.4(1) and 2.3.6(1)(ca) of the **Education and Training Reform Act 2006** (Act).

APPLICATION

3. This Order applies to every school council constituted under Part 2.3 of the Act.

GRANT OF LICENCE

4. (a) Subject to subclause (c), a school council to which this Order applies may grant a licence in relation to lands or buildings of the school or schools in relation to which the council is constituted for a purpose listed in subclause (b).

- (b) The purposes for granting a licence are –
- (i) to meet the objectives and perform the functions or duties of the school council; or
 - (ii) for educational, recreational, sporting or cultural activities for students, the local community or young persons.
- (c) This clause does not apply to the grant of a licence in relation to land or buildings to be used to operate a preschool program or programs for children.

Note: A licence in relation to land or buildings to be used to operate preschool programs must be granted in accordance with section 2.3.21 of the Act.

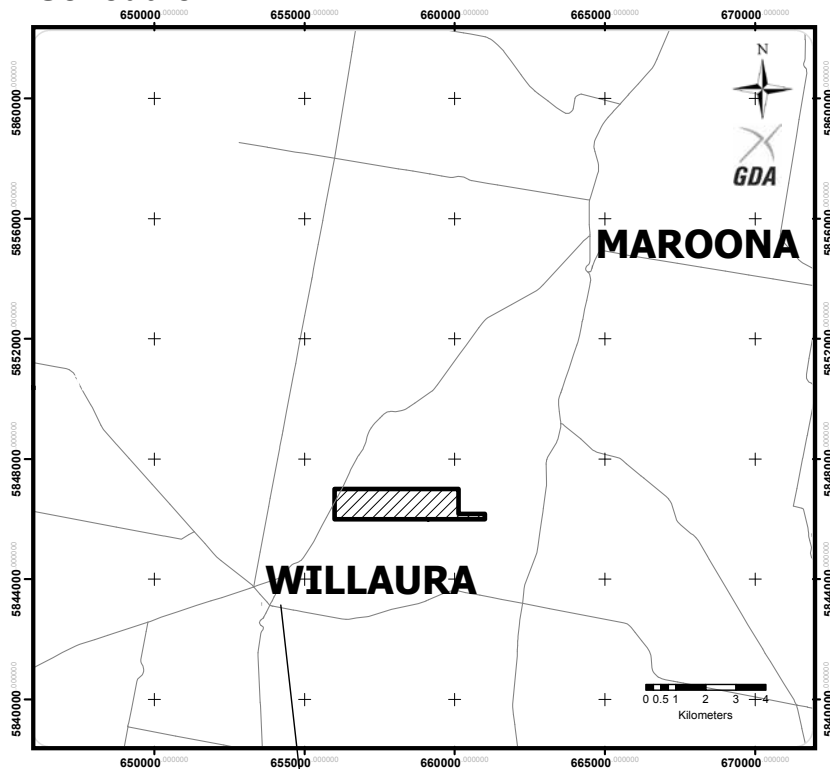

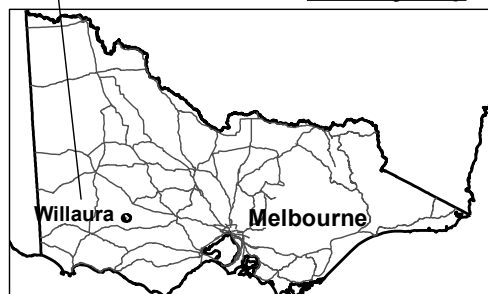

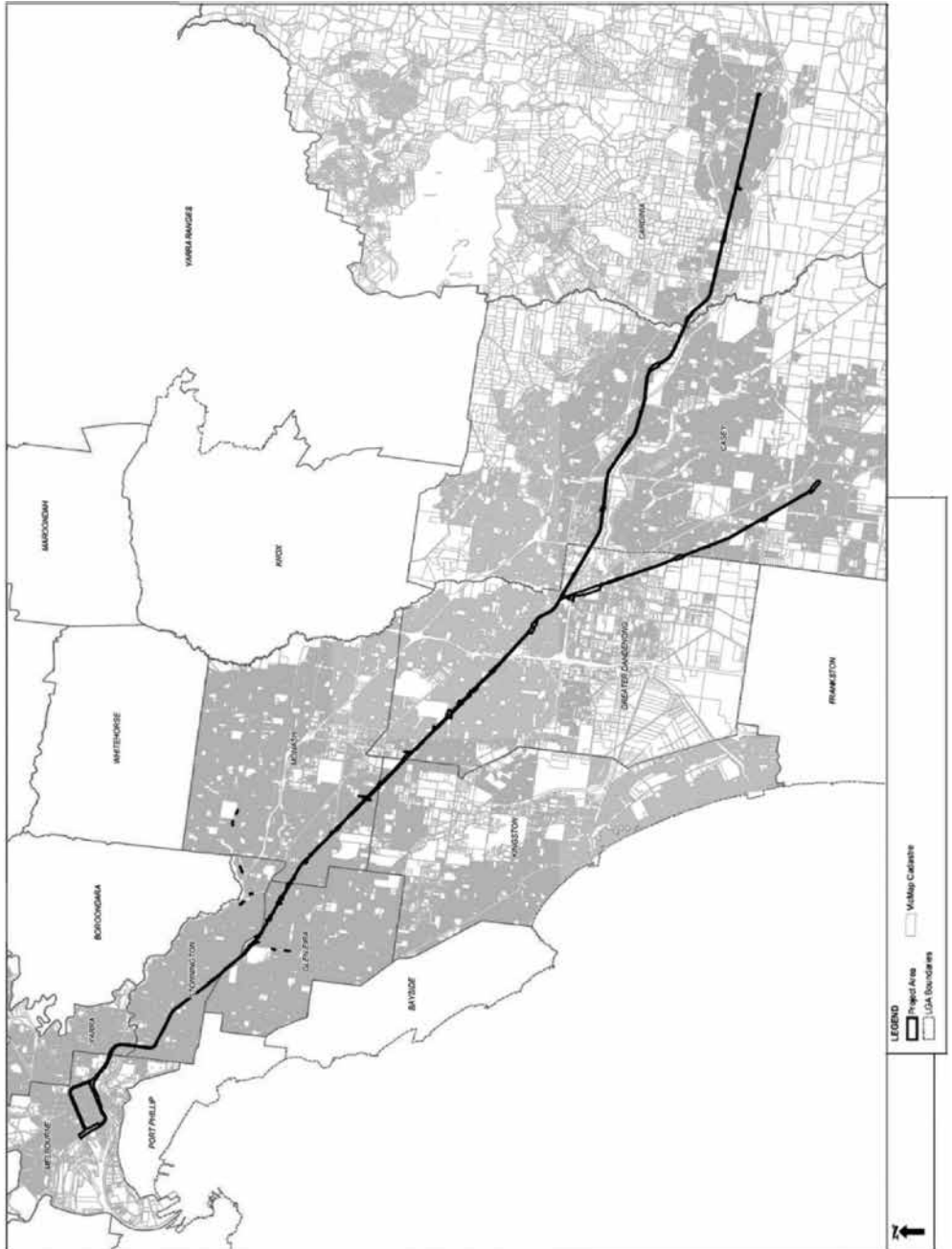

EXEMPTION ORDER UNDER SECTION 6(3A)

Order In Council

The Governor in Council makes the following Order:

1 Objective

The objective of this Order is to exempt certain persons from section 8A of the **Livestock Disease Control Act 1994**.

2 Authorising provision

This Order is made under section 6(3A) of the **Livestock Disease Control Act 1994**.

3 Revocation

The Order of exemption made under section 6(3A) of the Act by the Governor in Council on 27 November 2012 and published in Government Gazette S405 on Friday 30 November 2012 is **revoked**.

4 Definitions

In this Order –

APIQ means the Australian pork industry quality assurance program, owned and managed by Australian Pork Limited;

PIC means a property identification code as defined in the Act;

the Act means the **Livestock Disease Control Act 1994**.

5 Commencement

This order comes into operation on 1 January 2017.

6 Exemption

A person is exempt from the requirements of section 8A of the Act in the following circumstances:

- (a) if the person is moving, consigning, dispatching or transporting cattle, pigs, sheep or goats directly to a knackery; or

- (b) the person is an exporter of livestock or is acting on behalf of an exporter of livestock and is moving, consigning, dispatching or transporting cattle, pigs, sheep or goats directly to a port for export, which has been allocated a PIC commencing with '3PT'; or
- (c) where pigs are being moved directly from one property to another property and –
 - (i) the owner of the pigs and the property from which the pigs are moved operates under the APIQ program; and
 - (ii) the ownership of the pigs will not change by the movement; and
 - (iii) the on-farm records of both dispatching and receiving properties provide equivalent traceability; and
 - (iv) the owner of the pigs records the details of the movement of the pigs and keeps the record for 2 years.
