1	Welcome, introductions, apologies and actions from previous meeting		
	Meeting opened at 5:30pm.		
	 JW started with Acknowledgement of Country JW thanked Sorghum Sisters in Kensington for providing catering for the event JW read apologies JW advised that CLG members Denise Fry, Adam Vincenzinni and Scott Ellerton have resigned from their positions. Monique Perry has indicated she will replace Scott and represent Concerned Locals of Yarraville and WGTA are in the process of filing other vacant positions Attendees introduced themselves Status of open actions advised and specific actions to be reported on at next North and West meetings. 		
2	Year in review - West Gate Tunnel Authority		
	 PS welcomed all in attendance PS introduced the review of WGTA activities and achievements of 2018 PS advised of project parties involved in the West Gate Tunnel Project (WGTP) PS explained the government authorities operating within the Major Transport Infrastructure Program (MTIP): West Gate Tunnel Authority, North East Link Authority, Level Crossing Removal Authority, Rail Projects Victoria, Major Roads Project Authority PS advised of changes to ministerial portfolios following the state election PS presented benefits of building the WGTP PS provided an update of initiatives born from the Environment Effects Statement including the Community Involvement and Participation Plan (CIPP), Millers Road and Williamstown Road Corridor Study, Inner West Air Quality Reference Group, Moonee Ponds Creek Master Plan, various further traffic studies and other initiatives. PS advised that the CIPP was likely to be launched next year PS advised that the WGTA was funding noise mitigation works for front facing properties along Millers Road between Geelong Road and the West Gate Freeway FA enquired about the extent of the Moonee Ponds Creek Master Plan PS advised that the Scope was increased in response to community feedback and that the State Government was funding the Master Plan SM noted that the Inner West Air Quality Reference Group was, in part, formed to respond to the Planning Minister's decision not to include tunnel filtration for WGTP PS advised of significant funding from WGTA for community upgrades to the inner west that are being delivered as part of the West Gate Tunnel project PS committed to presenting further updates on the EES initiatives next year PS thanked all members for their ongoing contributions and to the Chair, and welcomed specific feedback on how the Community Liaison Group meetings are going so far. 		
3	 Landscaping and open space DL provided an update on the development of open space and landscaping 		
	designs related to the WGTP

- DL advised of the consulting role of Tract within the WGTP
- DL advised of stakeholder consultation conducted within the design development process. Groups consulted with include councils, Friends-of groups, heritage organisations and the Wurundjeri Tribal Council
- DL provided an overview of major construction packages which include landscaping and open space design development
- DL explained the design process from preliminary to final design drawings
- PB asked when during the design process does the community see the plans
- DL advised that plans are not directly presented to the wider community but are consulted on with stakeholder groups
- FA advised that the community groups which she represents have not been consulted about project works, only the Moonee Ponds masterplan and is not aware of how that feeds into the WGTP
- PB noted that part of the project requirements include talking to the community
- DL advised of the contractual requirements for the landscape design packages were as per the Urban Design Framework Report.
- FA asked why did stakeholder engagement not include community
- DA noted that council would be suggesting community are informed, not with a view to change the design, but to offer comments
- JW asked whether councils do have a responsibility to advise community of evolving landscape plans, and DA advised it was not councils responsibility to communicate the project landscape design
- DC advised that he will provide PB with a more detailed explanation of landscape design consultation requirements and that DL's presentation today formed part of the community consultation on landscaping
- FA asked if some of the landscape plans will be finalised before the Moonee Ponds Creek Master Plan commences
- DL advised that they are trying to find a middle ground with this
- FA asked who will be responsible for the management of the newly created open space areas
- DC advised that some areas are returned to various authorities for management while others are to be maintained by Transurban
- PB noted a number of concerns about the landscaping and open space plans:
 - the plans in the presentation were 51 weeks old when more recent preliminary designs were available and detailed designs were due to be issued to stakeholders next week
 - o When or how community consultation would occur
 - That some of these issues have been raised previously at CLG and haven't been addressed
- CF commented that he would like to see information shared with his community about this significant project
- DC advised that the drawings shown were part of the original design and that he will present updated versions to relevant stakeholders including CLG
- DC noted there were clear requirements in the contract and that community consultation was important.

- DC provided a look back at the construction milestones achieved during 2018
- DC noted the construction at the Northern Portal, North Yarra Main Sewer, ground condition monitoring and freeway widening
- DC presented footage of activities at the Northern Portal
- DC recognised the social inclusion and employment efforts of CPBJH

	 DC acknowledged the impacts of construction upon road users and advised that the project work to resolve any complaints which are received DC presented footage of the WGTP Information Centre Open Day on 22 September MP asked whether haulage routes for removing soil and rock from the Tunnelling Hub had been confirmed DC advised that while the final destinations for haulage were yet to be confirmed, trucks will exit the Tunnelling Hub via Whitehall Street and then onto Footscray Road DC advised that it is likely for a truck to be exiting the Tunnelling Hub approximately every 3 minutes, 24 hours each day DC noted that further information will be provided SG asked whether these trucks will be exempt from local curfews DC advised that they will not be exempt DC advised of the transporting of the Tunnel Boring Machine (TBM) "Bella" from China and it will take approximately four months to assemble before boring will commence in May 2019 DC thanked all CLG members for their input during 2018. A3 – DC to provide further information on the truck haulage routes and locations for disposal of spoil.

6 & 7	Construction update (East, West & Tunnels) & Year ahead
	 DH provided an update of excavation at the Northern Portal as well as the erection of a 250 tonne gantry crane CFb advised of the construction team's efforts to maintain access for road users during construction activities in the west construction precinct MP advised of flooding on the roadway at inbound freeway exit at Williamstown Road CFb advised that this is caused by issues with the local drainage network AP advised of activities in the east construction precinct including building demolition, completing the shared user path and upcoming pilling on Footscray Road.
8	Feedback on CLG from members & questions from members
	 DA asked what materials the new permanent noise walls for the WGTP would be made from CFb advised that noise walls are made from reinforced concrete plus acrylic panels in many areas GB asked where the site compound at Dudley Street and Footscray Road is accessed from AP advised that the entry is on Footscray Road, near Costco LL encouraged members to provide comments on how the CLG groups were being organised and run FA asked for members to be told which aspects of the project they could actively contribute to with input CF advised that more time needed to be spent at the meetings working through issues raised until resolutions were achieved, including an option for a more extended meeting or workshop SM commented that the VicRoads Millers Road and Williamstown Road Corridor Study be more closely aligned to the WGTP

	 KR suggested that a greater onus be placed on CLG members to provide information and ideas SG advised that members can be proactive in raising issues which are important to their local communities GM noted that the tea break is an excellent opportunity to share ideas with other members and project party attendees and that adequate time be allocated MP advised that the project presentations often ran over-time and as such, the time for member questions and input was cut back MM asked to see more information regarding traffic modelling in the Docklands area PB advised that he was more interested to learn about the impacts which the WGTP will have on communities rather than regular construction updates. WGTA noted this feedback from the CLG members and advised they will report back in the new year. JW thanked all attendees for their time and contributions.
