Tom McCann (TMc) Shondelle	Presentation covering overview of Manningham and Bulleen site activities using drone footage, 8 week work lookahead Overview of Manningham and Bulleen site activities
Mathews (SM) Ivan Zarezkij	FF: Where the asphalt is close to the headwall is that the final alignment of Bulleen Rd, are the road headers dug by a TBM? TMc: No, these are a SEM tunnel NMo: We will have more information on the final alignment in the next meeting FF: What will happen to Bridge Street in the final configuration? TMc: This intersection is undergoing a detailed design process in consultation with Council and Department of Transport. Currently, the design shows the slip lane to Templestowe Road will be removed, you will be able to turn left and right into Bridge Street from the intersection on Manningham Rd. SM: There will be more information to come on this, and we will keep you updated as the design for this area progresses During the construction phase there will also be long-term changes to the existing traffic arrangements in the area from early next year. You will receive more information about these traffic changes later this year.

	<b>MM:</b> Hudson has requested an update on Austin St parking CG: There have been night time lighting audits in February and July this year. The inspection in February found that there was a tree that required trimming and a light from trimming required and a light from United Energy out. The July inspection found that there were no issues with the lighting and it meets Councils expectation. The traffic team are still working on the parking restrictions, I will follow this up.

Joe Piasecki (JP)	<ul> <li>MM: What work is being done with traders in the North? IZ: They have their own Traders Association which has it's their own brand and most of the trader support has built on this. RM: They have 'open for business' hoarding but as they sit in between the tunnels and north package their branding is different. As Bulleen sits in the tunnels package only this should be easier to coordinate. RJ: SBMS can also help implement and develop this. CG: What is the timeframe for the branding to be finalised? IZ: We are hoping to launch this with a community activity before the end of the year. CG: We would be keen to work with you and help promote this. We have a Manningham Matters magazine that goes out to residents but unfortunately has a long lead time. We will also be launching a Find Your Local campaign in October, we will be asking people to create a reel showing their perfect day in Manningham which we can promote. We can hold the space for you if you would like to be in the December magazine.</li> </ul>

JP: Traffic management can be used as an entry point but there are real possibilities for them to have a career SM: We recently have some trainees that have become qualified supervisors. FF: How many apprentices have been brought on to the project? JP: Approximately 100 have been brought on (not all fulltime equivalents) FF: Are these jobs open to all genders? JP: Yes MM: How to get the message out about these opportunities? SM: We are working on a number of programs to engage with schools etc. MM: These could be advertised in the Council newsletters as well. CG: Is preference given to local business as part of the program? JP: The procurement team will look at the local businesses but for Spark to meet their Social commitments we need to be able to prove we are spending money with Victorian Aboriginal and Social Enterprise businesses. SM: If we are doing something locally we will try and work with local business wherever possible. TMc left at 5:55pm JP left at 6:35pm
Michael Hobbs (MH)	Presentation on Eastern Freeway Upgrades including overview of works, timeline to date, managing impacts and UDLP introduction
	FF: Will the timber noise walls be replaced? MH: They will be replaced where required to bring up to standard. SM: Will there be a reduced speed limit at the Eastern Freeway access point? MH: Yes, there will be reduced speed at access points and between Burke Rd and Tram Rd, this will cause very minor delays for motorists. FF: For the Doncaster Road underpass, will you need to go up and then across to get to Koonung Creek? MH: Yes, there will be some long term detours and we are working with Council and key stakeholders on this. FF: Will the Koonung Creek wetlands be preserved? MH: They will be reconstructed.
