Works Notification: Dynon Road

Works around Dynon Road as part of the West Gate Tunnel Project have commenced, with the start of construction for the new Dynon Road shared use path and bridges over Moonee Ponds Creek.

The West Gate Tunnel Project will provide direct link from Dynon Road to Flinders Street via the new Wurundjeri Way extension. It will also offer a new pedestrian and cycling bridge at Dynon Road, which will make it easier to cross Moonee Ponds Creek and the rail lines to link to the broader cycle network.

Dynon Road shared use path and bridges

Site Establishment in park reserve, between Miller Street and Anderson Street November 2019- December 2020

To enable construction of the new shared use path bridge at Dynon Road, we will be establishing a new worksite within the park reserve between Millers Street and Anderson Street (see map below), which will include the following activities:

- Fencing works;
- Worksite shed installation;
- Vegetation removal within work areas; and
- Identification of existing services.

These activities will be done during the day between 7am-5pm Monday to Saturday.

Piling works

Ongoing from October 2019

Piling works to construct the new shared use path and bridges over Moonee Ponds Creek and the rail yard, will be starting in late October. Works will require a series of rail corridor "occupations" to complete piling activity within the rail track area. These works will include:


- Piling preparation within the rail corridor; and
- Lane closures on Dynon Road to accommodate piling equipment

More information regarding the weekend rail occupations works will be advised closer to the date of works.

There may be some noise associated with this activity and we will work to minimise the impacts of this noise as much as possible.

Dryburgh Street intersection upgrade

Works to upgrade Dryburgh Street intersection have been postponed. More information will be provided to the community closer to the date of the works.



Shared-use path changes

Construction of the temporary shared use path along Capital City Tail is expected to start in **November**. The temporary shared use path will open in January 2020 and be in place for up to six months.

Additional temporary changes along the Capital City Trail and Dynon Road shared use path may be required as we complete works in the area. Shared use path switches will take place during off-peak periods and will be well signed for users.

Utility works

Utility works are taking place in the F-Gate and F-Gate areas will be ongoing for the next six months. Additional utility works will also be taking place along Dynon Road over the next three months.

Works may temporarily impact the shared use path. Traffic control will be in place to assist users.

F-Gate works

Piling works are required to construct the foundations for the piers that will support the new bridges to be constructed in F-Gate. Piling activity has commenced and will be ongoing throughout this quarter (see map above).

Piling activity includes a combination of driven, bored and sheet piling, pile cap preparation, pile break back, excavation and pier erection.

Investigations and drilling into the existing CityLink structure will also taking place **(ongoing to December)**, at the connection points for the ramp which will go over CityLink and connect to the West Gate Tunnel.

What to expect during construction

- Works completed both during the day and at night time.
- We will notify you if there are any significant changes to the timing of our works.
- Traffic management will be in place to manage changed conditions including temporary access changes and signage to guide road users and cyclists.
- Dust managed on-site.
- Piling works can create increased levels of noise and may also cause some vibration.
- Assessments have been conducted, which indicate the noise levels are expected to remain within permissible levels as documented in the project's Environmental Performance Requirements.
